**10:00 am - 3rd & 4th**  
**10:30 pm - 5th & 6th**  
**11:00 pm - 7th & 8th**

Times are approximate. There will be no breaks once wrestling begins.  
AWARDS: 1<sup>st</sup> place trophies, 2-4 medals.  
MATCHES: All age divisions 4 man round robin. 3 man where needed. Three one minute periods for Grades K-4.  
In the pre-K-2<sup>nd</sup> there will be a running clock. Grades 5/6 & 7/8 will wrestle three 90 sec periods.

**WEIGH INS:** Wrestlers weight will be recorded on registration form. Club coaches are responsible for verification of wrestlers weight. We will spot check up to 20% of the brackets in each division. If a wrestler is more than 3 lbs. over their entry form weight they will be disqualified with no refund. Challenge of opponent's weight will cost \$10. If wrestler is 3 pounds over stated weight he will be disqualified with no refund.
